GRSP will resume consideration on the work progress of the informal group on UN Global Technical Regulation (UN GTR) No. 7 Phase 2 and on its UN GTR proposal, if available.

7. Hydrogen and fuel cell vehicles

8. Regulation No. 14 (Safety-belt anchorages)

GRSP agreed to resume consideration of a proposal tabled by the expert from the International Organization of Motor Vehicle Manufacturers (OICA), aimed at exempting vehicles with one seating position per row from ISOFIX provisions and at introducing exemptions for vehicles not intended to transport children during normal use.

9. Regulation No. 16 (Safety-belts)

GRSP will consider a revised proposal aligning the text of the UN Regulation No. 16 with the air-bag label provisions recently introduced into UN Regulation No. 94 (frontal collision), prepared by the expert from Sweden. Moreover, GRSP might also wish to resume consideration on a proposal aimed at simplifying transitional provisions to the UN Regulation.

Moreover, GRSP might wish to resume consideration of the action undertaken by the Type Approval Authority of Hungary on withdrawal of the type approval of the belt guide device granted as a child restraint system according to UN Regulation No. 44.

Moreover, GRSP may wish to consider a proposal, prepared by the expert from OICA, to remove unnecessary constraints to electric vehicle systems having a working voltage of 48V and to adapt the safety provisions to this technology.
