2. Activities of United Nations Economic Commission for Europe (UNECE) bodies of interest to the Working Party

The Working Party will be informed about relevant decisions of the UNECE Inland Transport Committee (ITC) taken at its seventy-eighth session (23 to 26 February 2016).

SC.3 will be informed about the activities and work results of the Joint Meeting of Experts on the Regulations annexed to the European Agreement concerning the International Carriage of Dangerous Goods by Inland Waterways (ADN) and of the ADN Administrative Committee.

SC.3 will be further informed about the outcome of the Transport Security Forum held in Geneva on 17 June 2016.

4. Overview of activities of the Working Party on Inland Water Transport and its subsidiary bodies over the sixty years of its functioning

Following the decision taken at its fifty-ninth session to recall the main achievements of SC.3 over the sixty years of its existence as the theme topic of its sixtieth session, the Working Party may wish to consider the overview of its activities to be reported by the

secretariat. In this connection SC.3 may wish to discuss the most important activities and their added value for member States since the year of its creation, its main strengths, weaknesses, opportunities and challenges, as well as the relevance of its activities to the 2030 Sustainable Development Agenda.

5. Follow-up to the UNECE White Paper on Efficient and Sustainable Inland Water Transport in Europe: A new strategy and the Terms of Reference of SC.3

The Working Party may wish to comment on the revised version of a new strategy and Terms of Reference for SC.3 initiated at its fifty-ninth session and developed and revised by the Working Party on the Standardization of Technical and Safety Requirements in Inland Navigation (SC.3/WP.3) at its forty-eighth and forty-ninth sessions. The proposal was updated by the secretariat on the basis of the interventions of member States at the forty-ninth session of SC.3/WP.3 and comments received by the end of July. The Working Party may wish to discuss this version and propose any final amendments with the aim of finalising and adopting it at the session. SC.3 may also wish to ask the secretariat to transmit the document to the Inland Transport Committee for approval at its seventy-ninth session in February 2017.

6. European inland waterway network

(a) European Agreement on Main Inland Waterways of International Importance (AGN)

The Working Party may wish to share information about progress in the realization of the European Agreement on Main Inland Waterways of International Importance (AGN).

Following its decision to continue collecting Government's amendment proposals for 2–3 years before proceeding with a new amendment to AGN, the Working Party may wish to start discussion on the next package of amendments based on the third revision of the Inventory of Main Standards and Parameters of the E Waterway Network ("Blue Book").

(b) Inventory of Main Standards and Parameters of the E Waterway Network ("Blue Book")

The Working Party may wish to approve amendments to the Blue Book approved by SC.3/WP.3 at its forty-eighth and forty-ninth sessions and further updates submitted by member States for the draft third revision of the Blue Book (ECE/TRANS/SC.3/WP.3/2016/3, ECE/TRANS/SC.3/WP.3/2016/12 and Corr.1, Informal documents SC.3/WP.3 Nos. 2 and 24 (2016)). The secretariat will present the draft third revision of the Blue Book. The Working Party will be invited to adopt the third revision the revised Blue Book and give instructions to the secretariat, if any, on the format of the final publication.

The Working Party may wish to note that the secretariat was asked by SC.3/WP.3 to prepare draft amendments to Resolution No. 49 for its fiftieth session in February 2017 on the basis of the third revision of the Blue Book. SC.3 may also wish to request that SC.3/WP.3 consider possible differentiations of bottlenecks with the aim of prioritising them appropriately.

(d) Good Navigation Status of European inland waterways

The Working Party will be informed about a study on "Good Navigation Status", funded by the European Commission (EU) in the framework of the EU Regulation on the trans-European Transport Network (TEN-T) which requires all waterways of the TEN-T network to feature a "Good Navigation Status" in 2030 at the latest. SC.3 is invited to take part in the discussion of the Good Navigation Status concept, possible aligning of the concept with UNECE instruments and applicability of this concept to the E Waterway network.

7. Standardization of technical and safety requirements in inland navigation

The Working Party may wish to note that SC.3/WP.3 held two sessions in 2016: the forty-eighth session on 17–19 February 2016 and the forty-ninth session on 22–24 June 2016 (ECE/TRANS/SC.3/WP.3/96 and ECE/TRANS/SC.3/WP.3/98). The Working Party may wish to endorse the activities carried out by SC.3/WP.3 in 2016 and provide guidance as appropriate.

(a) European Code for Inland Waterways (CEVNI) (Resolution No. 24, revised)

The Working Party may wish to take note of amendment proposals to the fifth edition of the European Code for Inland Waterways (CEVNI) prepared by the secretariat on the basis of consultations with member States, River Commissions and decisions of SC.3/WP.3. SC.3 may wish to decide on the next meeting of the CEVNI Expert Group.

The Working Party may wish to exchange information on the updating of the CEVNI status document and the questionnaire on regional and national special requirements. SC.3 may also wish to note that translations of CEVNI in languages other than UNECE working languages are available on SC.3 home webpage. The Working Party will be informed on the release of the CEVNI poster.

The Working Party will be invited to approve the draft and give instructions, if any, to the secretariat on the format of the final publication.

The Working Party may wish to consider a new amendment proposal to Resolution No. 61 submitted by the Russian Federation, as set out in ECE/TRANS/SC.3/2016/10.

SC.3 may wish to continue discussion on the amendments proposed by the Group of Volunteer Experts on Resolution No. 61: proposal for the new Section 8B-4 (Requirements concerning equipment for the treatment of domestic waste water) and draft Appendixes 8 and 9 (ECE/TRANS/SC.3/2015/8), proposal for amending Chapter 23 and Appendix 2 and proposal for a new Chapter 24 (ECE/TRANS/SC.3/2015/9). In this connection SC.3 may wish to decide on the further work and the next meeting of the Group of Volunteer Experts on Resolution No. 61.

The Working Party may also wish to consider the preparation of the consolidated version of Resolution No. 61 on the basis of the adopted amendments, as recommended by SC.3/WP.3 at its forty-ninth session.

SC.3 may wish to exchange information on this subject and potential further steps.

SC.3/WP.3 may wish to decide on the dates of the next meeting of the International Expert Group on Mutual Recognition of Boatmasters' Certificates and Harmonization of Professional Requirements in Inland Navigation (IEG) and on its provisional agenda.

9. Promotion of River Information Services (RIS) as well as other Information and Communication Technologies (ICT) in inland navigation

(a) Follow-up of the workshop

The Working Party will be informed about the outcome of the workshop "River Information Services and other information communication technologies in the pan-European format" held during the forty-ninth session of SC.3/WP.3 and the decisions taken (ECE/TRANS/SC.3/WP.3/98). SC.3 may wish to exchange information on the implementation of RIS at a national level and to determine issues for further consideration emanating from the outcome of the workshop. SC.3 may also wish to discuss how to enhance the coordination of work and cooperation between UNECE and other relevant organizations towards harmonizing technical standards.

(b) Current status and further updates to UNECE Resolutions No. 48, 57, 58, 63, 79 and 80

Given that SC.3/WP.3 decided to wait for the adoption of relevant EU instruments with a view to ensure the coherent application of RIS standards at the pan-European level and to create equal and transparent conditions for all involved, SC.3 may wish to decide as appropriate.

The Working Party may wish to invite Governments to keep the secretariat informed of any further modifications or additions to the document.

The Working Party may wish to encourage them to apply only Resolution No. 40.

11. Recreational navigation

(a) Workshop “Recreational navigation and water tourism: Prospects and challenges”

- recreational navigation and water tourism: best practices, prospects and challenges;
- pleasure craft chartering and routes for recreational navigation;
- the International Certificate for Operators of Pleasure Craft (ICC): skills and training, issuance, application and recognition.

Following the workshop, delegates may wish to discuss the next steps for the Working Party in this area.
