

## **Updated provisional agenda for the sixty-ninth session**

### **1. Adoption of the agenda**

### **2. UN Regulation No. 9 (Noise of three-wheeled vehicles)**

The Working Party on Noise (GRB) will be informed that the proposals for the 08 series of amendments, which had been adopted by GRB at the previous session (ECE/TRANS/WP.29/GRB/66, para. 3 and Annex II), were submitted to WP.29 and to the Administrative Committee (AC.1) for consideration and vote at their March 2019 sessions.

### **5. UN Regulation No. 92 (Replacement exhaust silencing systems for motorcycles)**

GRB will note that the proposals for the 02 series of amendments, which had been adopted by GRB at the previous session (ECE/TRANS/WP.29/GRB/66, para. 10) were submitted to WP.29 and AC.1 for consideration and vote at their March 2019 sessions.

## 6. UN Regulation No. 138 (Quiet road transport vehicles)

The Informal Working Group (IWG) on the Quiet Road Transport Vehicles (QRTV) Global Technical Regulation (GTR) will report on its activities. GRB will also be informed about the outcome of its request of WP.29 to extend the mandate of QRTV UN GTR until December 2019.

## 7. Tyres

### (a) UN Regulation No. 30 (Tyres for passenger cars and their trailers)

GRB will consider proposals by the experts from the European Tyre and Rim Technical Organization (ETRTO) that clarify and improve the text of UN Regulation No. 30.

### (b) UN Regulation No. 75 (Tyres for motorcycles/mopeds)

GRB is invited to consider a proposal submitted by the expert of France which clarifies the identification, marking and test provisions applicable to tyres designed for speeds above 240 km/h.

### (c) UN Regulation No. 117 (Tyre rolling resistance, rolling noise and wet grip)

GRB is invited to consider a proposal submitted by the expert from the Netherlands which introduces two extra stages 3 and 4 with limits for the rolling sound emission, wet grip performance and rolling resistance coefficient.

GRB will consider a proposal prepared by the expert from the Russian Federation that aligns the approval numbers and markings of UN Regulation No. 117 with the provisions of Schedule 4 of the revised 1958 Agreement.

## **9. Exchange of information on national and international requirements on noise levels**

GRB will continue the exchange of views on developing national or regional legislation and international requirements concerning noise levels.

## **10. Influence of road surface on tyre rolling sound emissions**

GRB will be informed about progress on this issue since the previous session of GRB in September 2018 and will discuss an updated text of the draft Resolution on Road Surface Labelling prepared by the expert from the Netherlands.

## 12. Development of the International Whole Vehicle Type Approval system

GRB will review a candidate UN Regulation No. 138 (QRTV) proposed to be added in Annex 4 of UN Regulation No. 0 in IWVTA Phase 2 and will decide on priorities.

GRB may wish to specify whether some UN Regulations under its responsibility shall explicitly ban the use of the "Unique Identifier" as specified in Revision 3 to the 1958 Agreement.

- Transitional provisions in UN Regulations

GRB may wish to define an action plan to align the transitional provisions in UN Regulations in line with the provisions of the 1958 Agreement, e.g. the possibility to grant type approval according to previous versions of UN Regulations.

- Article 12.6 and Schedule 7

GRB may wish to note the purpose of Article 12.6 and Schedule 7 with regard to the approval of innovations.

- Conformity of Production provisions

GRB may wish to define an action plan to align the Conformity of Production (CoP) provisions in UN Regulations and amend references on CoP in UN Regulations.

- Communication form and approval numbers

GRB may wish to define an action plan to address the proposal of the IWG on IWVTA on the approval number format in communication forms (as per Schedule 4 of the Agreement) for approvals defined in UN Regulations within the scope of GRB.
