The Ministry of the Sea, Transport and Infrastructure of Croatia presents its compliments to the ADN Administrative Committee of the UN Economic Commission for Europe and has to honor to address with the following.

Taking into consideration entering of the Bureau Veritas Marine & Offshore SAS into the list of classification societies, based on the subsection 1.15.2.4. of Annexed Regulation to the Waterways (ADN), after the „Bureau Veritas Marine & Offshore SAS“ has fulfilled the recognition procedure, confirmed by the decision of the Administrative Committee on session in Geneva 19th January 2008., about recognition of the classification society „Bureau Veritas Marine & Offshore SAS“ as recommended ADN classification society, I decide to recognize classification society „Bureau Veritas Marine & Offshore SAS“ by „Decision on Recognition of Classification Company Bureau Veritas Marine & Offshore SAS“ from July 29, 2019. godine (ODLUKA o priznanju klasifikacijskog društva Bureau Veritas Marine & Offshore SAS od 29. srpnja 2019. godine – in attachment).

The Ministry of the Sea, Transport and Infrastructure has received a request from the Bureau Veritas Marine & Offshore SAS in which they request recognition of their classification society.
