

# 2. Report on the last sessions of the World Forum for Harmonization of Vehicle Regulations (WP.29)

The Working Party on Pollution and Energy (GRPE) may agree to consider a brief oral report by the secretariat about the highlights of the March 2019 sessions of WP.29 on issues related to GRPE.

#### 3. Light vehicles

(a) UN Regulations Nos. 68 (Measurement of the maximum speed, including electric vehicles), 83 (Emissions of  $M_1$  and  $N_1$  vehicles), 101 (CO<sub>2</sub> emissions/fuel consumption) and 103 (Replacement pollution control devices)

GRPE may wish to consider proposals to amend UN Regulations Nos. 68, 83, 101 and 103, if any.

(b) UN Global Technical Regulations Nos. 15 (Worldwide harmonized Light vehicles Test Procedures (WLTP)) and 19 (Evaporative emission test procedure for the Worldwide harmonized Light vehicle Test Procedure (WLTP EVAP)).

GRPE may wish to consider proposals to amend UN GTRs Nos. 15 and 19, if any.

GRPE will receive a status report on the activities of the IWG on WLTP, as well as a status report on the transposition to UN GTR No. 15 into UN Regulation.

(c) Worldwide harmonized Real Driving Emissions test procedure.

GRPE will receive a status report on the activities of the IWG on RDE

#### 4. Heavy duty vehicles

(a) UN Regulations Nos. 49 (Emissions of compression ignition and positive ignition (LPG and CNG) engines) and 132 (Retrofit Emissions Control devices (REC));

GRPE may wish to consider proposals to amend UN Regulations Nos. 49 and 132, if any.

(b) UN Global Technical Regulations Nos. 4 (World-wide harmonized Heavy Duty Certification procedure (WHDC)), 5 (World-Wide harmonized Heavy duty On-Board Diagnostic systems (WWH-OBD)) and 10 (Off-Cycle Emissions (OCE))

GRPE may wish to consider proposals to amend UN GTRs Nos. 4, 5 and 10, if any.

(c) Worldwide provisions for Heavy Duty vehicles Fuel Economy.

GRPE may wish to receive a status report on the activities of harmonized provision for Heavy Duty vehicles Fuel Economy, if any.

5. UN Regulations Nos. 24 (Visible pollutants, measurement of power of C.I. engines (Diesel smoke)), 85 (Measurement of the net power), 115 (LPG and CNG retrofit systems), 133 (Recyclability of motor vehicles) and 143 (Heavy Duty Dual-Fuel Engine Retrofit Systems (HDDF-ERS)).

GRPE agreed to consider a proposal prepared by the expert from Italy aiming at establishing the conditions to consider direct and indirect injection vehicles as being part of the same approval family.

GRPE may wish to consider a proposal prepared by the expert from the International Organization of Motor Vehicle Manufacturers (OICA) to amend in UN Regulation No. 85 the wording of the description of auxiliaries to be fitted for testing in order to reduce potential testing burden.

GRPE may wish to consider proposals to amend UN Regulations Nos. 96 and 120, if any.

(b) UN Global Technical Regulation No. 11 (Non-road mobile machinery engines)

GRPE may wish to consider proposals to amend UN GTR No. 11, if any.

7. Particle Measurement Programme (PMP)

GRPE will receive a status report from the IWG on PMP.

- 8. Motorcycles and mopeds
- (a) UN Regulations Nos. 40 (Emission of gaseous pollutants by motorcycles) and 47 (Emission of gaseous pollutants of mopeds)

GRPE may wish to consider proposals to amend UN Regulations Nos. 40 and 47, if any.

(b) UN Global Technical Regulations Nos. 2 (World-wide Motorcycle emissions Test Cycle (WMTC)), 17 (Crankcase and evaporative emissions of L-category vehicles) and 18 (On-Board Diagnostic (OBD) systems for L-category vehicles).

GRPE may wish to consider a proposal by the IWG on EPPR to amend UN GTR No. 2.

## (c) Environmental and Propulsion Performance Requirements (EPPR) for L-category vehicles

GRPE will receive a status report from the IWG on EPPR.

#### 9. Electric Vehicles and the Environment (EVE)

#### (a) UN GTR on the Determination of Electrified Vehicle Power (DEVP)

GRPE will receive a status report on the development of a UN GTR on DEVP.

#### (b) Other activities of the IWG on EVE

GRPE will receive a status report from the IWG on EVE.

#### 10. Mutual Resolution No. 2 (M.R.2)

GRPE may wish to consider a proposal to amend Mutual Resolution No. 2 (M.R.2), if any.

#### 11. International Whole Vehicle Type Approval (IWVTA)

GRPE will receive a report by its Ambassador or its Chair on IWVTA.

GRPE agreed to receive an update from contracting parties on the compliance of GRPE related UN Regulations with the provisions.

#### 12. Vehicles Interior Air Quality (VIAQ)

GRPE will receive a status report from the IWG on VIAQ.

Following the endorsement by GRPE at its last session of the extension of the mandate of the IWG on VIAQ until November 2020, GRPE may wish to consider the final version of the terms of reference and rules of procedure of the IWG.

#### 13. Exchange of information on emission requirements

GRPE may wish to receive an update from EC on the post Euro 6/VI process, and how it could impact the activities of GPRE in the future.

GRPE may wish to consider an exchange of views on the development of national or regional legislation and international requirements concerning emissions.

#### 14. Election of Officers

In compliance with Rule 37 of the Rules of Procedure (TRANS/WP.29/690/Rev.1), GRPE will elect the Chair and Vice-Chair of the sessions scheduled for the year 2020.

#### 15. Any other business

GRPE may wish to consider a proposal from the expert from OICA to amend Consolidated Resolution on the Construction of Vehicles (R.E.3), on the recommended market fuel quality.
