1. Adoption of the agenda

The first item to be considered is the adoption of the agenda.

2. Workshop: "The development of international passenger rail transport in the context of ITC Resolution No.264"

The Working Party may wish to consider the workshop on "The development of international passenger rail transport in the context of ITC Resolution No.264". International passenger transport by rail remains fundamental to the movements across borders. In current times, with increased attention on the environmental impact of aviation travel leading to many travellers switching to rail, as well as in the aftermath of the COVID-19 pandemic international rail travel is of increased importance. This workshop will discuss the role of the rail sector in international passenger transport with a focus on how to recover post-COVID-19 and how to further increment its market share by incentivising its use. Background statistical information has been prepared by the secretariat in document ECE/TRANS/SC.2/2020/5.

A summary of the workshop will be prepared following the session on the findings.

3. European Agreement on Main International Railway Lines

Status of the European Agreement on Main International Railway Lines and amendment proposals

The Working Party may wish to be informed by the secretariat about its activities to increase the number of Contracting Parties to the European Agreement on Main International Railway Lines (AGC Agreement). Detailed information on the AGC Agreement, including the up-to-date and consolidated text of the Agreement (ECE/TRANS/63/Rev.4),¹ a map of the AGC network, an inventory of compliance with AGC standards and the relevant Depositary Notifications are available on the website of the Working Party.

Further information will be provided at the session about the notification of changes to the AGC agreed at previous sessions of the Working Party, as well as ongoing work aimed at the modernisation of AGC and improving its accessibility (ECE/TRANS/SC.2/2020/4).

The Working Party may wish to be informed about the preparation of a document setting out the background, benefits and accession requirements for the AGC as requested by delegates at the seventy-third session of the Working Party (ECE/TRANS/SC.2/2020/2).

The Working Party may also wish to discuss a proposal to extend the AGC to include main passenger railway hubs of international importance to further facilitate the growth in international passengers by rail (ECE/TRANS/SC.2/2020/3)

The Working Party will be updated on efforts being undertaken to update the joint AGC-AGTC online tool on technical parameters for operation on the E-Rail network.

4. Railway financing and Public-Private Partnerships

The Working Party may wish to recall that at its seventy-third session it approved the creation of the Group of Experts on the Permanent Identification of Railway Rolling Stock. This has subsequently been approved by ITC (ECE/TRANS/294, para. 101) and by EXCOM. The Working Party may wish to be informed about the work to date of the Group of Experts.

The Working Party may also wish to be informed about other developments including the UNECE Guiding Principles for People-First Public-Private Partnerships for the United Nations Sustainable Development Goals as well as the role of Public-Private Partnership projects being undertaken in the rail sector.

5. Towards unified railway law in the pan-European region and on Euro-Asian transport corridors

The Working Party may wish to recall that Inland Transport Committee (ITC) at its eighty-second session (25 to 28 February 2020, Geneva) and the Executive Committee of the Economic Commission for Europe had approved the extension of the mandate of the Group of Experts on Unified Railway Law for one more year to complete the work (ECE/TRANS/294, para. 100).

The Working Party may wish to be informed about the progress of meetings in 2020 and discuss the next steps in preparing URL noting that the first meeting for 2020 was cancelled due to COVID-19 restrictions leading to a postponement of discussions which will now run into 2021.

Under this agenda item, the Working Party may wish to discuss the status of the 2006 Convention on International Customs Transit Procedures for the Carriage of Goods by Rail under cover of SMGS Consignment Notes. The Working Party on Customs Questions affecting Transport noted that this Convention has not attracted much attention from countries and at the moment has no contracting party (ECE/TRANS/WP.30/308). SC.2, through the Group of Experts on Unified Railway Law has discussed at length the combined CIM-SMGS consignment note based on other legal instruments, it may wish to discuss this issue further in the working party session and identify reasons why there have been no contracting parties to this Convention.

7. Euro-Asian rail transport

Following the seventy-third session a summary publication was prepared by the secretariat and is available on the Working Party Webpage.

The Working Party may wish to be informed about and discuss new developments on Euro-Asian rail transport corridors, its involvement in developing the Euro-Asian Transport Links (EATL) project, including the results of the recent meetings covering EATL and developments in relation to the "Sustainable Inland Transport Connectivity Indicators".

Following on from the decision of the Working Party at its seventy-second session, the Working Party may wish to be informed about developments in the Eurasian Rail Alliance Index (ERAI).

10. New convention on the facilitation of crossing of frontiers for passengers and baggage carried by rail

The Working Party may wish to discuss next steps on this subject in light of discussions on international passenger transport under agenda item 2.

The Working Party may wish to recall that it agreed to the creation of a rail innovation observatory aimed at sharing with member States best practice innovations that could further help develop the competitiveness of the railways, assist in achieving Sustainable Development Goals (SDGs) and work towards the achievement of technology pillar of the ITC Strategy. The Working Party may wish to be updated on the creation of the observatory.

The Working Party may wish to discuss the updated questionnaire set out in document ECE/TRANS/SC.2/2020/7.

13. Climate Change and Rail Transport

(a) Group of Experts on Climate Change Impacts and Adaptation for Transport Networks and Nodes

The secretariat will inform the Working Party about the work of the Group of Experts on Climate Change Impacts and Adaptation for Transport Networks and Nodes and especially about the work to be done which is relevant to rail transport.

(b) Climate Change mitigation and the For Future Inland Transport Systems tool

The Working Party will be informed about the developments in 2019 of the For Future Inland Transport Systems (ForFITS) project. The aim is to develop and implement a monitoring and assessment tool for carbon dioxide emissions in inland transport, including a transport policy converter to facilitate climate change mitigation. The Working Party may wish to discuss ForFITS and railways.

(c) Green logistics, eco-scoring and related matters

As per the decision on this agenda item at the seventy-third session, the Working Party will may wish to be informed about the interactions of the secretariat and UIC on this issue. It may also wish to discuss aspects related to green logistics, eco-scoring and related matters.

14. Railway Reform

The Working Party may wish to be informed about the developments on railway reform, building on the workshop held at the seventy-first session of the Working Party.

15. Facilitation of international rail transport in the pan-European region

(a) Facilitation of rail border crossings

(b) Harmonization of technical specifications on different railway systems

The Working Party may wish to be informed by the Organization for Cooperation between Railways (OSJD) and/or the European Union Agency for Railways (ERA) about improvements in the 1,435 mm and the 1,520 mm broad gauge railway systems, and about the results of the work of the OSJD/ERA Working Group on Interoperability.

The Working Party may wish to recall that at its seventy-third session, it had discussed document ECE/TRANS/SC.2/2019/7 setting out investment related data on projects and the mapping of this information on a GIS platform.

The Working Party may wish to discuss this topic further.
