> GRSP is expected to receive the final report by the Chairman of the AISOFIX@ group, and to take a decision concerning the choice between the top tether and the supporting leg for the AISOFIX@ system. GRSP also agreed to continue consideration of the proposal which had been transmitted to WP.29 and of the proposal by OICA for a global technical regulation.

2.2. <u>Regulation No. 16</u> (Safety-belts)

TRANS/WP.29/GRSP/26, GRSP agreed to resume consideration Paras. 32 and 33 of the proposals by Japan and CLEPA (informal documents Nos. 14 and 7 of the twenty-sixth session) 3/.
