- 1. This event is organized in collaboration between the United Nations Economic Commission for Europe (UNECE), the Ministry of Investment, Industry and Trade and Ministry of Transport of Uzbekistan as a national seminar to build capacity on digitalizing data and document exchange in the SPECA region using United Nations standards. It is a response to the demand of the delegations of Uzbekistan and other States participating in the United Nations Special Programme for the Economies of Central Asia (SPECA) at the SPECA Governing Council on 23 November 2023 in Baku that UNECE organizes capacity-building on the use of the standards of the UN Centre for Trade Facilitation and Electronic Business (UN/CEFACT) in the rollout of the Trans-Caspian Corridor Digitalization Roadmap.
- 2. The Presidential Summit of the States Participating in the United Nations Special Programme for the Economies of Central Asia (SPECA) on 24 November 2023 adopted the SPECA "Roadmap for the digitalization of multimodal data and document exchange along the Trans-Caspian transport corridor, using United Nations legal instruments and standards", 1 prepared with support from UNECE in 2022-2023. The Roadmap envisages action for the digitalization of multimodal data and document exchange along supply chains in the Trans-Caspian Corridor, using the semantic standards and Multimodal Transport Reference Data Model (MMT RDM) of the United Nations Centre for Trade Facilitation and Electronic Business (UN/CEFACT).
- 3. The idea for this Roadmap for digitalization of multimodal data and document exchange along the Trans-Caspian and other SPECA corridors came at the International High-level Conference "Digital Transformation of Information Exchange in Supply Chains Using United Nations Standards", Baku, Azerbaijan, 31 October 2022. In their Joint Ministerial Statement from 17 April 2023, the SPECA Ministers

requested "the UNECE to develop a Roadmap for a digitalization of multimodal data and document exchange along the trans-Caspian transport corridor using relevant United Nations standards, including through realizing a regional pilot project for SPECA participating States". UNECE started such a project, together with TRACECA, for the digitalization of the CIM/SMGS railway consignment note along the Trans-Caspian Corridor. At the seminar in Tashkent, we will invite Uzbekistan to join this and launch other multimodal data and document exchange projects.

- 4. The problem that we seek to address is the fragmentation of digitalization efforts in the supply chains in this and other SPECA corridors. The solution we suggest is to base information flows about cargo moved along multimodal digital trade and transport corridors on alignment with UN/CEFACT's global semantic standards and Multimodal Transport reference Data Model (MMT RDM).
- 5. In this sense, the seminar will seek to:
 - a. Identify business requirements for the digital exchange of data and documents among various modes of transport and sectors in supply chains in the SPECA corridors,
 - b. Assess the availability of technical skills in Uzbekistan to implement the international standards for harmonized digitalization of multimodal transport data and document exchange; raise awareness and capacity of the participants to digitalize data and document exchange aligned with the UN/CEFACT standards and reference data models,
 - c. Explore the possibility of establishing "centre(s) of expertise" in Uzbekistan, comprising business and IT experts, who will learn the details of using the UN/CEFACT semantic standards and MMT RDM to be used in practical digitalization projects for multimodal data and document exchange,
 - d. Review progress in the implementation of the UNECE-TRACECA pilot project on the digitalization of a railway consignment note (CIM/SMGS); consider including other Central Asian countries in it; explore the possibility to start new pilot projects (e.g., for road, air, and interoperability of data exchange),
 - e. Discuss the possibility to develop software for the digitalization of trade and transport documents accompanying goods (consignment notes, bills of lading and additional documents) to link to the Single Window in Uzbekistan,
 - f. Discuss other possibilities for concrete pilot testing projects of the digitalization of information exchange in collaboration with development partners.
- 6. The target audience of this seminar will include policymakers and experts with technical skills from the relevant national agencies dealing with digitalization, trade regulation, transport, and transit procedures, as well as the business community (traders, transporters, freight forwarders, IT developers, etc.). This is a capacitybuilding event to generate skills in the target countries to implement the innovative approach of harmonized digitalization of data and document exchange along a digital corridor.
- 7. Discussions on the contribution of UN standards and involvement of international organizations and the private sector with a view to formulate the conclusions and recommendations on the next steps and pilot projects to support relevant initiatives in the region.
