- facilitating the harmonization of national mineral reserve classification systems and mutual recognition of mineral reserve experts and competent persons based on UN standards: UNFC and Requirements for Qualified Experts.

- implementation of Russian and international programmes aimed at solving urgent problems in the field of sustainable management of natural resources
- drafting regulations and guidance documents
- case studies and writing bridging documents between national classifications and the UNFC
- elaboration and implementation of training and advanced professional courses for students, experts and competent persons in the field of subsoil use



DEVELOPMENT OF THE EXPERT COMMUNITY

Model Requirements for Experts in Estimation of Reserves, Resources and Development of Mineral Resources and to Competent Persons

The adoption of the Model Requirements, based on the UN Competent Expert Requirements, creates new opportunities for:

- mutual recognition of experts and competent persons between partner countries
- trust in experts and competent persons and confidence in the quality and reliability of their judgements
- broad involvement of experts and competent persons by partner countries for various purposes (expertise, audit, training, creation of new projects and research areas, estimation, development and subsoil development technologies)
- creation of unified standards/approaches to reporting, expertise (audit) of reserves, agreed and adopted by all participating countries
