Main characteristics

✓ Target population – all private households (residents) / not individuals, absence data about institutional households

✓ Type of information - Income, non-wage income, transfers, employment, durable goods, education, health, housing, agricultural activity, food production, consumption, and etc.

✓ National concept

✓ All private households, exclusion data about institutional households

Other sources


✓ Income statement of financial organisations

>Absence of information about institutional HH

Missing data income and consumption sides both macro and micro levels

Macro – micro gaps are large even the data are excising in macro and micro levels

Next steps

Short-term

✓ To find other statistical and administrative microdata sources

✓ Suggestions to Armstat for making changes in questioners and adding new fields and questions for estimation some important items in micro level especially in income sides

Long-term

✓ Applying the methods based on EG DNA recommendation for imputation missing data

✓ Aligning micro data with national accounts totals

✓ Clustering households into household groups
